

# **CLAIMS IN HEARING**

## Chathams WAI 64

The Moriori inquiry was opened in the Chatham Islands 9-13 May, and continued the following week, 16-20 May, in Wellington.

The claim concerns the failure of the Crown to recognise and protect Moriori customary rights to land and fisheries on Chatham and outlying islands, following petitions and requests from Moriori leaders from the 1850s through to the 1880s. The claimants allege that these Treaty breaches occurred through the operations of the Maori Land Court and the Crown's refusal to

review those operations. The claim also alleges that the Crown failed to protect the Moriori people from oppression and destruction, and failed to recognise them as tangata whenua of the Chathams, with all the functions and privileges that such a status entails.

Te Runanga o Wharekauri Rekohu Inc attempted to stop the hearing through a High Court restraining order, claiming that the Waitangi Tribunal does not have the jurisdiction to inquire into the decisions of previous Courts. The High Court said the Runanga's arguments were not valid, hence, the inquiry proceeded.

#### Whanganui River WAI 167

The tribunal has heard evidence from Whanganui iwi relating to its claim to the Awa o Whanganui at hearings at Putiki Marae in Whanganui from 14–18 March and 18–22 April 1994.

Evidence presented has focused upon traditional uses of the river, including fishing and transport, the tribe's metaphysical relationship with the river, and the contemporary problems of pollution, headwater diversion and low water-levels.


Further iwi evidence as well as Crown and third party evidence is scheduled for hearings in June and July.

## Turangi Lands WAI 84

At a hearing at Hirangi Marae in Turangi from 5–8 April 1994, Ngati Turangitukua claimants presented evidence concerning their grievances arising from the development of Turangi township from 1964.

The township was developed in connection with the Tongariro Hydro scheme. Lands for the township were acquired from the Ngati Turangitukua hapu under special legislation, the Turangi Township Act 1964, which granted the Crown extensive powers of compulsory acquisition.

The Crown will present its evidence to the tribunal in Turangi in August.

The report on the Ngai Tahu ancillary claims is currently in draft form. The tribunal hopes to finalise the report for release to the Minister of Maori Affairs by the end of the year.

## Goodbye to Judge Ashley (Chick) McHugh

Judge McHugh has retired from his position of Deputy Chief Judge of the Maori Land Court, formally, although not actually, ending his role as a presiding officer for some of the tribunal inquiries. He is known for his tremendous effort in presiding over the Ngai Tahu claim, on which he is still working; the ancilliary Ngai Tahu claims have yet to be reported to government and Judge McHugh has a temporary warrant to complete that matter.


## FAREWELLS


